ANNOUNCEMENTS:

1) The District 11 Executive Board has asked Maricopa County Recorder, Helen Purcell, and her staff to prepare the ballot and conduct the District 11 Reorganization Election meeting on Tuesday, November 25, 2008. The County Recorder's charge to the District for this service will be \$1200. At Ms. Purcell's request, the currently serving Nominating Committee met with her staff for a planning session at the County Recorder's Offices on Oct 4.

At this meeting, it was determined that in order to prepare the ballot, the Recorder's staff must have the candidates' names for District Officers and State Committeemen by October 27. This means that, because of the Bylaw requirement for a ten day notice to potential candidates to submit their names, it will be necessary to mail, by October 15, the "Call" letter announcing the November 25th meeting.

As a consequence of the timing limitation, the currently serving Nominating Committee will be required to send the "Call" notice. The newly elected Nominating Committee will fulfill the remaining responsibilities for the reorganization election.

Again, because of time limitations, our Webmaster, George Teegarden, has been designated as the person to notify to add your name to the ballot.

The District 11 site, www.trugop.org, will contain a link with a daily update of candidates who have submitted their names to be on the ballot. If you have submitted your name, and it does not appear on this list by Oct 25, call George at 602-996-4010 to ensure your name is on the list submitted to the Recorder on Oct 27. A name submitted after 7pm on October 25, will not appear on the ballot and will have to be nominated from the floor on November 25, as a "write-in" candidate.

2) There will be **no** District 11 **meeting** on **Nov 11**. We **moved** the Nov 11 meeting **to Nov 25** because of the AZ Statutory District Reorganization timing requirements. These requirements mandate that the reorganization meeting must be conducted no earlier than the second Saturday following the General election and no later than the first Saturday of the following December.
