# **Credentials Committee Registration Rules**

**Due to the very large number of Precinct Committeemen (400 in person or by Proxy) that must be registered (approaching the numbers registered at a County or State meeting):**

- 1. The registration duration has been expanded to 90-minutes (6:00PM to 7:30PM) from the usual 60-minutes. There will be multiple Registration Lines (we are planning for eight [8] lines) grouped Alphabetically by Precinct Name.**
- 2. Even with this time expansion, it means that we must register approximately four (4) Precinct Committeemen/Proxies per minute. With eight lines that allows approximately 2-minutes to register each PC, or Proxy. Therefore, each Precinct Committeeman, or Non-PC Proxy Carrier will be allowed only one trip thru the Registration Lines!! This means that anyone carrying Proxies *must have them ALL completed for submission prior to their one trip* through the Registration Lines!!!**
